

Photo License Agreement

concluded on in Szczecin by and between:

The University of Szczecin, al. Papieża Jana Pawła II 22a, 70-453 Szczecin, represented by Vice-Rector for Organisation, dr hab. Kingę Flagę-Gieruszyńską, prof. US, hereinafter referred to as the Licensee,
and

....., domiciled in at street, a holder of personal identity proof series no, hereinafter referred to as the Licensor,

of the following
content:

§ 1

1. Under this Agreement the Licensor grants the license, authorising the use of photos taken by the Licensor within the framework of the photography competition promoting student mobility in the Erasmus+ programme entitled "ERASMUS plus ME", to the Licensee.
2. The photos, referred to in Paragraph 1, shall be handed over under a delivery-acceptance report.

§ 2

1. The Licensor declares that the photos, referred to in § 1 of the Agreement, constitute an independent and original piece of work within the meaning of the Act of Copyright and Related Rights.
2. The Licensor declares that, as the author of the photos, he/she is entitled to economic rights.
3. The Licensor declares that the pieces of work, referred to in § 1, do not violate economic or personal rights of third parties.

§ 3

The Licensee declares that she is the Organiser of the "Erasmus plus ME" Competition lasting from May 5, 2022 to May 31, 2022.

§ 4

1. The Licensor grants the Licensee an exclusive license free of charge for photos referred to in § 1 and authorises the Licensee to use the photos by means of:
 - 1) reproduction of photos on digital media;
 - 2) multiple fixation and multiplication of the photo by any technique, including audio-visual, on any media, without limitation as to the quantity and size of the circulation;
 - 3) introducing to computer networks, the Internet, including in particular, displaying the photos on the University of Szczecin website and Facebook profile, the Intranet, the TV;
 - 4) projecting the photos on educational fairs, in schools, on conferences organised by the University of Szczecin, for the purposes of the delivery and promotion of the Competition as well as for all activities necessary for sharing the photo and delivery of the Competition;
 - 5) other forms of display aimed at the promotion of the University of Szczecin;
2. The Licensor grants the Licensee an unlimited license to use the photos.

3. The Licensor authorises the Licensee to use the photos within the territory of the Republic of Poland and to the unlimited use within the framework of the Internet network.
4. The Licensee may authorise other people to use the piece of work within the framework of the granted license.

§ 5

The authorisation, referred to in § 4 of the Agreement, is free of charge. Any costs related to the conclusion of this Agreement and the use of photos shall be borne by the Licensee.

§ 6

The Licensee is obliged to respect the Licensor's right to maintain the inviolability of the content and form of the photos.

§ 7

The Licensor has the right to terminate this agreement with immediate effect if the Licensor determines that the Licensee uses the photos in a manner inconsistent with the provisions of this Agreement.

§ 8

To matters not covered by this Agreement, the relevant provisions of the Act on Copyright and Related Rights and the provisions of the Civil Code shall apply.

§ 9

All and any amendments to this Agreement shall require a written form, otherwise being null and void.

§ 10

Any disputes that may arise based on this Agreement shall be settled by the court competent for the Licensee.

§ 11

The Agreement has been concluded in two identical copies, one for each of the parties.
