VICE-RECTOR FOR ORGANISATION OF THE UNIVERSITY OF SZCZECIN

of August 10, 2026

on the rules for allocating places in student dormitories to students incoming on international exchange in the 2026/2027 academic year

Due to the insufficient number of places available in Student Residence Halls of the University of Szczecin for all incoming international exchange students admitted for the 2026/2027 academic year, the following rules for the allocation of accommodation places shall apply:

- 1) priority will be given to students with disabilities;
- 2) second priority will be given to students admitted under bilateral agreements, as these students come from outside the European Union and do not receiving funding from EU programmes;
- 3) third priority will be given to students admitted under Erasmus+ KA171, as these students receive their scholarships only upon arrival and are mostly from geographically distant countries;
- 4) final priority will be given to students admitted under Erasmus+ KA131, based on the distance between the seat of the University of Szczecin and the seat of the partner institution, as calculated using the European Union calculator used in the Erasmus+ programme, starting with the highest distance. If the number of students from a particular partner institution exceeds the number of available places, allocation will be determined in alphabetical order, taking into account specificity of the available place (male or female room).

Those who are not awarded places will be placed on a reserve list, in the order indicated above. Those on the reserve list will be provided with information on websites where they can find offers for private accommodation for the duration of the exchange.

If a person who has been awarded a place resigns from the exchange, the place will be allocated to the next person on the reserve list.
